My Independent witness has been irreparably tainted by corrupt D.Y. police
The Barman has been irreparably tainted by corrupt D.Y. police

Why is the police issuing subpoena's to all my witnesses a week out from trial.
Should not they have questioned these people before I was charged? My council has
already issued them subpoenas. Is this so that the police can now say in court that they
have talked to these witnesses?

This is farcical. My next point is far from farcical, the allegation I am about to make
is extremely sinister and a far more serious crime than what I have alleged to have
committed

On Friday just gone, the police went to [REDACTED] home, (the independent witness)
issued him the subpoena, and then made comments so extreme, so blatantly biased,
that they have virtually crippled my independent witness, and therefore tainted the
whole trial. They said many things to [REDACTED], and he is presently writing down all that
he can remember. The reason I know this is that he rang both my solicitor and my
barrister about this matter and some of the suggestions made by police were relayed to
me, but there are far worse and more numerous statements alleged than the following
that were relayed to me

1)-that the police have cctv evidence that I came over the top and bashed Shane
Bullock unconscious and then hit him a further 10 times while unconscious before
dragging his unconscious body and dumping it in the street

I have examined the cctv footage and there are no punches thrown from either
side recorded. 2 other men are clearly seen dragging Shane's body onto the street

2)-that [REDACTED] was the only independent witness to side with Dirk and why is he
protecting such a vicious thug (or words to that effect) who had beaten Shane to
within an inch of his life-

I struck Shane with 4 blows after he dislocated my jaw and was in the process
of bashing the barman. Shane was at the football next day drinking beer and laughing
with his mates

3)-That Dirk had a terrible reputation.

If this is so, why have the police never questioned me?

4)-there were many, many other things said to [REDACTED] that my solicitor did not tell me,
but they were along the same lines

[REDACTED] has asked my solicitor why he is "sticking his neck out for a man capable of
such things". Remember, this man has to live in his community and has a fused neck
where one punch will kill him, and drinks in the same hotels as Bullock and his
cronies He stated that he now feels very uneasy and is beginning to waver. Please
recall that I would not even be standing trial had the police conducted an adequate
investigation to start with. They did not interview the sober people concerned and not
only did not ask anyone from the top floor who would have seen the assault on
me(numbered over 100), but put an add in the paper midweek asking for witnesses to

“an assault on a patron”, meaning anyone on the top floor who saw me assaulted would think it was a different fight to the one that they saw (me being king hit), and not ring the police for this reason.

On Friday just gone, the police rang my barman, my next most crucial witness, and asked him to come into the station to pick up his subpoena. While he was there he was grilled on his recollection of events. When Troy the barman said that Shane had “king hit” Dirk with incredible force and that he (the barman) was standing right there watching, the police “scoffed at his account” and proceeded to tell him their version of events, which included a bouncer holding on to each arm while I bashed Shane unconscious and continued to hit him after he had lost consciousness. Troy said to my solicitor that he felt threatened and intimidated. Again, he is writing down everything that the police said and they will be made in to statements.

Mamm, I was honest on the night of the incident, and I have been honest in everything I have told you in the last 9 months or so. These latest facts can be easily verified. The investigation was a charade, the arrest unlawful, and the charge way over the top. The investigation into my investigation was blatantly whitewashed. Now my main witnesses are being blatantly tarnished. I will not plead guilty to a lower charge as so many before me, I am putting my life on the line to prove a point. I am doing this so it can never be done to anyone again, and as previously mentioned, if I can now somehow negotiate my way through a now corrupted trial and still be found not guilty, I will never rest until these corrupt officials are forced to be held accountable for their actions, as I have had to be.

Mamm, when are you going to step in and do your job?

To the PIC and the Ombudsman

Tomorrow I am sending an audio tape of my interview with a very polite and sincere sounding Inspector Brownlow to both your organisations. On this tape are my explosive allegations of widespread corruption and the information needed to prove them. Also enclosed is a media release and my one way correspondence since our meeting. Even though he went out of his way to make me feel as though he was impartial, his station has too much to lose for him to expose so many of his colleagues. I have set a trap. I am totally committed to the cause. I feel so strongly about this matter that I am willing to risk everything to expose this endemic corruption. I have backed myself into a corner by letting the media know what's happening. I know a copy of the media release will make it's way to the police and they will be even more determined to charge me as the only way the media can comment is if the charges are dropped. By doing this, I have forced them to have to continue on with this blatant setup and it's resulting cover up because it involves so many officers. I want to see how far they are willing to go to continue covering up this deepening crisis that they are facing. To see how far the rot goes. What they are willing to do.

How many are sitting in jail now because of these officers? How many would have gone to jail if our paths had not crossed? This is a bitter fight for survival on both sides. If they succeed in destroying me, then who else is there to take up the fight? Many of my brothers in the security industry are semi-illiterate. I owe it to all of them as I am in a unique position to stop them due to my literacy persistence, intelligence, courage, resilience and durability.

I want to believe him but the stakes are too high. This has gone too far now for them to stop. How can he be impartial when he too tried to palm me off with his initial attempt at a whitewash. How can he investigate colleagues of equal or higher rank? I realise these are unconventional tactics but desperate times call for desperate measures.

At best- 3 inspectors, 5 detectives and 8 uniform lower ranked officers are involved in this conspiracy.

At worst? Who knows.

Also enclosed is the follow up emails I have sent with no reply.

They have taken my dignity. They have taken my wealth. They have taken my name and rubbed it in the dirt. They have tried to take my honour, but they will never take my spirit.

The only regret I have with this strategy is that my independent witness/witnesses may be exposed to harm.

Over the weekend I attempted to send you my final message before trial or no bill, however, your sheriff barred me so I am sending you the letter I sent to Karen from the Daily Telegraph in particular and the media in general.

I know it is political but I am a fiercely patriotic, genuinely concerned citizen and I have taken every step possible in this fight for justice. Justice not just for me, but for an undetermined number.

I have questioned the very system, structure and implementation of the law regarding the security industry and the units that govern it.

I have fought shoulder to shoulder with the police on many occasions and consider myself to be a moral citizen who polices society behind the scenes.

I make no excuses and demand to be held accountable at all times. But this has to work both ways and that is what I am fighting so hard for

As promised, you will not here from me again until no bill or trial's end.

The only question I have is how long does it take for an investigation of this magnitude.

I would certainly hope that a finding that answers the questions I have raised is found before my trial
